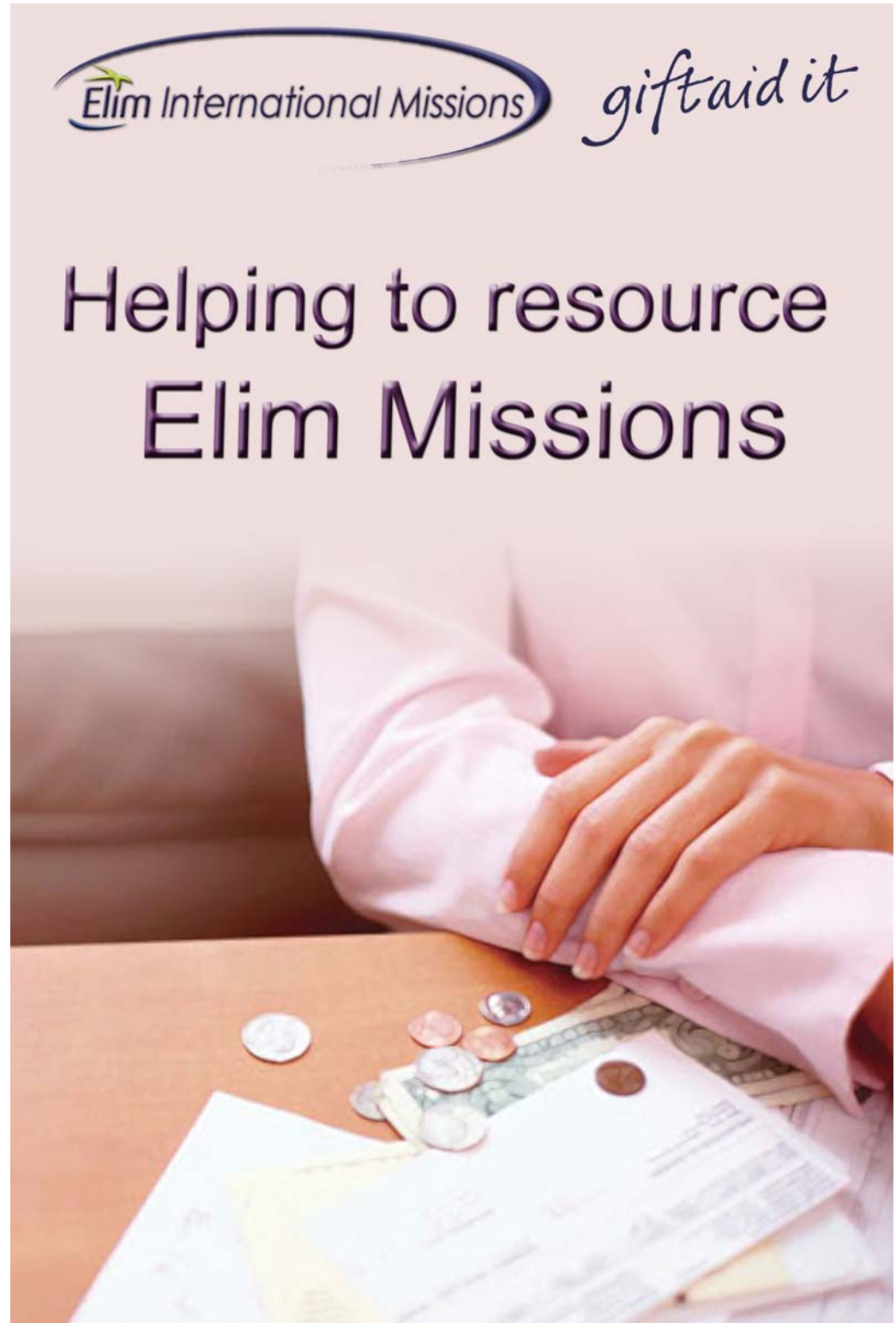

Sponsoring/Resourcing an Elim ministry:

Thank you for your interest in supporting Elim International Missions. Whether you decide to make a one off donation or become a regular donor, your support is very much appreciated. If you are a UK tax payer, we can increase the value of your support through the Gift Aid scheme.

How does Gift Aid work?

For every pound you give as a UK tax payer, we as a charity can recover 28 pence from the Inland Revenue, helping your donation go further.

This means that £100 can be turned into £128 just so long as donations are made through Gift Aid.

Can anyone give by Gift Aid?

Where gifts are made in sponsorship of an individual's ministry, they cannot be made by immediate family, i.e. not wife or husband; a relative (sibling, ancestor or descendant); the wife or husband of a relative.

Also, what you pay in UK income tax or capital gains tax must at least equal the amount we will recover in the tax year.

The benefits of Gift Aid

- * **No extra cost to you**
Yet your giving increases significantly.
- * **No minimum amount**
Tax is reclaimable on all Gift Aided donations.
- * **No minimum period of commitment**
One declaration can last indefinitely, yet can be cancelled should your circumstances change.

Direct Debit Guarantee



- * This Guarantee is offered by all Banks and Building Societies that take part in the Direct Debit Scheme. The efficiency and security of the scheme is monitored and protected by your own Bank or Building Society.
- * If the amounts to be paid or the payment dates change EFGA will notify you 7 working days in advance of your account being debited or as otherwise agreed.
- * If an error is made by EFGA or your Bank or Building Society you are guaranteed a full and immediate refund from your branch of the amount paid.
- * You can cancel a Direct Debit at any time by writing to your Bank or Building Society. Please also send a copy of your letter to us.
